**Discussion on Budget:** Adam Davis- Expected Budget for year \$4,000.00: \$700.00 to convention, \$1,500.00 Direct Outreach, \$500.00 for Fundraising, \$50.00 General Supplies, \$500.00 Candidate funding, \$500.00 Marketing, and \$200.00 for fee on the website. \$50.00 General Use Fund. Brendan made a motion to move \$200.00 from Direct outreach to Contingency fund if approved. Kenny Pola seconded, budget was approved.

Appropriated Funds will be given to delegates to go to the National Convention-Brendan Phillips made a motion to raise the budget to \$4,250.00 and appropriating \$250.00 to go to pay delegate registration fees. Dee Taylor seconds, If delegates waive registration fee it can be given to someone else or carried over to the next year. **Motion approved**.

Adam Davis would like additional funds moved to Candidate funding, Pride tables, events, etc. Donation from the party to campaigns, will not specifically earmarked.

Adam Davis made a motion to approve budget as amended in this meeting. Brendan Phillips seconded. **Motion approved**.

**National Delegate Report**: voted and elected Coordinated Campaign candidates, all got elected except for one. Steering Committee election ended four days ago. Tony Ndege was elected. Many upcoming proposals: sex worker amendment, population control amendment.

GPAX is proposing a speak peace manual for National Committees. We need some outreach and training on how to speak to each other.

GPAX proposing that a statement be made against the military parade.
